Dear Secretary of State,

I am writing to you today to bring to your attention (if it is indeed necessary), the actions of the British Security Services (most likely MI5 and GCHQ) and some of their international allies, in a pernicious and relentless attack on my life, which has resulted (amongst other things) in me being labelled as a long-term sufferer from a mental health condition, a diagnosis which is completely fabricated.

These elements of the British State appear to be operating on behalf (to a large extent) of the whole unelected, unrepresentative and, indeed, anti-democratic regime which has existed in this country for many, many years and maintains its grip on power by any means necessary, no matter how dirty or underhand.

I have been subjected to:

- all-pervasive covert surveillance using every possible means
- a complete destruction of my rights as a free citizen, which includes the removal of all aspects of any kind of private existence
- a broad and extensive campaign of psychological terrorism, using all sorts of manipulative and dark practices, which appear to be the forte of these agencies
- a campaign of denigration and character assassination directed at the general public behind my back
- the very strong possibility of illegal medical operations carried out to implant very high-technology bioelectronic devices in and on my person, to aid and assist this war against me
- the development and commissioning of Artificial Intelligence systems used to destroy my ability to live my life, by automatically producing simulations which are relayed to the public, in an attempt to trash my life
- false imprisonment for over 30 months, in total, in mental health institutions, where the activities of those who perpetrate these crimes, continued unabated
- the imposition of anti-psychotic medication for many years of my life, without there being any valid reason at all for this to be done

- an overwhelming degree of covert control of my life, which I presume, is to prevent there being any threat to those who have perpetrated this action against me. It is very likely, in fact, that there lies behind all of these pernicious and highly criminal activities, where the rule of law has to a large degree been thrown out the window, replaced by a tyranny, some very dark and disturbing secrets which if exposed would be extremely damaging to both, individuals and the State itself.

Everything has been deliberately hidden from me – one of the key rules which the perpetrators appear to have enforced (perhaps by threat of serious sanction) is that I must never be enlightened in any way, about any of the activities which underpin this long-running campaign against me. My detractors have also made this action against me, a worldwide phenomenon, which prevents me from living any sort of normal life anywhere on the planet. I have not been able, despite much thought, to come up with any answer to the question ‘Why?’. It simply appears that these people, for whatever reason, have taken it upon themselves to destroy my life, just because they can. My response has been to some extent, to use the platform provided to me by this ‘covert’ surveillance and broadcast, to attempt to tell a story of a better way of living together in a society which, instead of being based on cynicism and human character traits associated with cynicism, is based on values which build communities, and are focused on enhancing every citizen’s life, rather than just those in the elite cabal. My enemies in the unelected British State, and their allies, have attacked me in the public eye, but behind my back, to undermine any foothold my ‘story-telling’ might take in the public’s minds.

I have spent a long time fighting back against this attack on me, and one of the things I am pursuing, is the complete expunging of my mental health record from my overall medical record. I have lived in England for much of my life so a lot of the associated false mental health record was compiled in England, but I now live in Scotland, and have been also ‘imprisoned’ falsely in a mental health institution here (in Inverness), so part of my false record is held by NHS Scotland.

It is not clear to me who has the overall authority to expunge my false mental health record, so I am writing to you, as Health Secretary, as you will have the powers to follow through on my demand to the NHS (across Great Britain) to completely expunge this false record.

What I ask from you, is that you firstly, recognise the full validity of this war against me primarily by the British Security Services, and then do everything possible to force the NHS across the whole country, to expunge my false mental health record.

## Supporting Information – Definition of a Simulation/Impersonation

Any impersonation using any medium to execute it as follows:

- Digital Text
  - . Email
  - . SMS
  - . Messaging Apps
  - . Social Media
- Abuse of Phone number (or previous phone numbers)
  - . Simulated incomplete Phone calls (where abused number appears on target device)
- Voice
  - . Digital synthesis (phone calls, voicemails, broadcast audio channel)
  - . Physical vocal impersonation
- Hand-Written text
  - . Handwriting forgery
  - . Signature forgery
- Physical impersonation
  - . Any digital interface between me (as a member of the public) and digital systems in widespread use by the public
    - . eg use of Bank Card - contactless and Chip and Pin
    - . eg bar codes used for entry to signed-up-services, such as Aberdeen Sports Village
    - . eg membership cards which are uniquely attached to me and are used against digital systems
  - . Any of the above generated by AI systems based on inputs from devices attached to my person
