Dear Madam/Sir,

I am writing to you today because you held the position of either Home Secretary or Foreign Secretary at some point during the period from 2000 up to the present day. As Home Secretary, the person in this position has overall responsibility from a political standpoint for MI5. As Foreign Secretary, the person in this position has overall responsibility for MI6 and GCHQ.

During the period in question I occupied the following places of residence:

I have extremely convincing (although circumstantial) evidence that at most of these places of residence I was under covert surveillance by security services for reasons unknown. This surveillance appears to be all-pervasive and may well have started at some point in the period 2001 – 2004, but was almost certainly in place by 2005. It is also very likely that invasive surgery was performed on me without my knowledge, under the “guidance” of the security services during a period where I was hospitalised, to place upon and within my person, high technology surveillance devices to enhance the capability of those services to monitor my every movement, almost literally.

As a senior government member responsible for these security services at some point during the period in question, can you please answer the following questions:

- Did you personally authorise covert surveillance action to be taken against me?
- Do have any knowledge of any kind of the imposition of covert surveillance upon my person?
- Does the Home/Foreign secretary have full political control of these security organisations?
- Do these security services take direction from members of the unelected, unrepresentative, anti-democratic British state – specifically the Head of State and entourage – at any time to take action and begin operations such as covert surveillance?
- Are the security services under the authority exclusively of the elected government, or are they in fact agents of the Head of State?

It is my very strong belief that the security services have been directed by the previous and current Head of State to impose a regime of all-pervasive cover surveillance and associated psychological terrorism against my person, completely destroying my freedom and my rights as a citizen of Great Britain.

I would greatly appreciate your frank and honest response to this situation which has lasted for at least 20 years. I also understand that this is a difficult issue given that everyone seems to be frightened of these people, but if what I suggest is true, they must be held to account. I hope you will agree.

Thank you for your time considering this issue, and I look forward to your reply as soon as is possible.
