Dear Mrs Obama,

I am writing to you today to raise your awareness (if it is necessary) of a situation I find myself in which has persisted for at least 20 years. Before I launch into that, I want to express my best wishes to you and all your family. Your girls are grown-up by now I would think, and I hope they are enjoying to the full all of the activities in which are engaged. I hope also that your husband is extremely well and I'm sure he is always busy and in great demand. I think that it is likely that from your husband's time as President, he may well have been aware of my situation, even back then. Both of you are inspirational to many people, and I watched clips of your speeches to the Democratic Convention prior to the US election last year. Your persona allows you to shine when you speak, and you are a fantastic role model for all, but in particular for female African Americans, and others from an African background worldwide.

It's a great shame that the outcome of the election in the States was as it was.

Now, on to my difficulties! It appears that I have been the focus of covert attention by the Security Services of the British State for at least 20 years, for reasons unknown. For all of this time, and more, I have been put under all-pervading covert surveillance, had my whole life broadcast on the internet to the world, and had to put up with a huge campaign (imposed by agencies and technology organisations internationally) of digital impersonation in all sorts of ways.

It is also the case, in my estimation, that in the 2010's I was illegally operated on without my knowledge, and a number of bioelectronic devices were implanted in various parts of my body. These devices, along with the covert audio and video surveillance appear to provide inputs to a remote digital AI system which can be used to generate automatically an infinite of digital simulations which can be easily modified to suit any changes or developments.

It seems also to be the case that international security services are involved in this situation, including, I believe, the CIA and NSA. I have a connection to the US as I worked for 14 years for Hewlett Packard, visiting the States many times, and I believe that the main thrust of the activities directed against me started whilst I was employed by HP, who appear to have been fully complicit.

The focus of all of this seems to be an obsessive desire to control me and my life.

I have tried everything I can think of to escape from this metaphorical prison, where my rights and freedoms are completely disregarded by the British State and their allies, but to no avail. Because I have no privacy, they always remain one step ahead, and the people who are in charge of these activities are ruthless, to the point of psychopathy, subjecting me day-and-night to what amounts to psychological torture. I have even been subjected to 'imprisonment' in mental hospitals for more than 24 months in total, despite there being nothing wrong with me.

My response to all of this has been to identify which parts of the British State system are responsible, and using my platform, which provides video and audio access to the general public (worldwide) to promote ideas for change, in particular in Britain, which would go a long way, in my view, to preventing this sort of collective personal attack on an individual citizen from happening again.

I believe that it is likely that you are aware of my situation (as it seems are many people worldwide!) so this letter may not come as a surprise. What I need more than anything, is a full disclosure of what has been done to me for the past 20+ years. Can I rely on you to provide it?

Any impersonation using any medium to execute it as follows:

- Digital Text
 - . Email
 - . SMS
 - . Messaging Apps
 - . Social Media
- Abuse of Phone number (or previous phone numbers)
 - . Simulated incomplete Phone calls (where abused number appears on target device)
- Voice
 - . Digital synthesis (phone calls, voicemails, broadcast audio channel)
 - . Physical vocal impersonation

- Hand-Written text
 - . Handwriting forgery
 - . Signature forgery
- Physical impersonation
- . Any digital interface between me (as a member of the public) and digital systems in widespread use by the public
 - . eg use of Bank Card - contactless and Chip and Pin
 - . eg bar codes used for entry to signed-up-services, such as Sports facilities
 - . eg membership cards which are uniquely attached to me and are used against digital systems
- . Any of the above generated by AI systems based on inputs from devices attached to my person
