Dear Mr. Windsor,

I am writing to you today to bring to your attention (as if it were necessary), the actions of the British Security services (MI5 and GCHQ) and some of their international allies, in a pernicious and relentless attack on my life instigated by the previous Head of State, and carried on with your full commitment and support. You are all quite clearly, members of the club defined as the unelected, unrepresentative and, indeed, anti-democratic regime which has existed in this country for many, many years and maintains its grip on power by any means necessary, no matter how dirty or underhand. It is my clear view that your regime is responsible for the following:

I have been subjected to:

- all-pervasive covert surveillance using every possible means at all of the following residential addresses:

- a complete destruction of my rights as a free citizen, which includes the removal of all aspects of any kind of private existence
- a broad and extensive campaign of psychological terrorism, using all sorts of manipulative and dark practices, which appear to be the forte of these agencies
- a campaign of denigration and character assassination directed at the general public behind my back
- illegal medical operations carried out to implant very high-technology genetically-engineered bioelectronic devices in and on my person, to aid and assist this war against me – a completely overwhelming intrusion into my personal space and privacy

- the development and commissioning of Artificial Intelligence systems used to destroy my ability to live my life, by automatically producing simulations which are relayed to the public, in an attempt to trash my life
- false imprisonment for around 36 months, in total, in mental health institutions, where the activities of those who perpetrate these crimes, continued unabated – British State operatives, all staff and patients alike
- the imposition of anti-psychotic medication for many years of my life, without there being any valid reason at all for this to be done
- an overwhelming degree of covert control of my life, which I presume, is to prevent there being any threat to those who have perpetrated this action against me. It is very likely, in fact, that there lies behind all of these pernicious and highly criminal activities, where the rule of law has to a large degree been thrown out the window, replaced by a tyranny, some very dark and disturbing secrets which if exposed would be extremely damaging to both, individuals and the State itself, including, I strongly suspect, your family

Everything has been deliberately hidden from me – one of the key rules which you have enforced (by threat of serious sanction against members of the public) is that I must never be enlightened in any way, about any of the activities which underpin this long-running campaign against me. You and your fellow perpetrators have determined to absolutely isolate me and control my life in every single way.

You have also made this action against me, a worldwide phenomenon, which prevents me from living any sort of normal life anywhere on the planet. I have not been able, despite much thought, to come up with any answer to the question ‘Why?’. It simply appears that you and your agents have taken it upon yourselves to destroy my life, just because you can. My response has been to some extent, to use the platform provided to me by this covert and illegal surveillance and broadcast, to attempt to tell a story of a better way of living together in a society which, instead of being based on cynicism and human character traits associated with cynicism, is based on values which build communities, and are focused on enhancing every citizen’s life, rather than just those in the elite cabal. You, in the unelected antidemocratic British State, and your allies, have attacked me in the public eye, but behind my back because of your collective cowardice, to undermine any foothold my ‘story-telling’ might take in the public’s minds.

I take the very strong view that you and your predecessors, going back for generations, are brought up to be tyrants, mostly quietly, but when the need arises completely openly, suspending the rule of law whenever you see fit – a law which you and all of your circle sit outside of, owning all the means and mechanisms of implementation, so that members of the general public – treated entirely by you as your subjects – are refused access and defence if you so dictate.

You and your agencies and allies have sewn chaos and misinformation deliberately undermining any efforts to resolve this situation in a just and positive way. You have built secret alliances and infiltrated groups whose objectives clash with your own. You have tried to create the impression that this whole thing is about personal issues and that you are a benevolent force simply trying to bring peace and harmony to bear. It is necessary to bring to everyone’s attention that this is all lies, and that you and your agencies are deliberately perpetuating chaos.

What justification do you have for your and your predecessor’s actions, along with all the agencies and organisations you have used to undermine and control my life?

As a free citizen who recognises not a scrap of your claimed authority over me, I demand honest and clear answers. Provide them to me.
